Previously, she held several positions at the Elisabeth Glaser Pediatric AIDS Foundation, and served in the Clinton Administration at the White House and the Treasury Department.

He has also served as a Steering Committee Member of the Decade of Vaccines Collaboration and Co-Chair of its Global Access Working Group, as well as President, Committee on Global Health, American Society of Tropical Medicine & Hygiene.

Since 2013, Dennis has participated in annual World Polio Day events. Dennis presented at Rotary's World Polio Day: Making History (2013 & 2016) event - viewed in 15+countries by 11,000+ viewers. From 2012 to 2017, Dr. Schluter was on detail from CDC to the World Health Organization (WHO) Western Pacific Regional Office, serving as the Group Lead for Accelerated Disease Control for the Expanded Program on Immunization Unit providing support to the 37 countries and areas of the Western Pacific. From 2009 to 2012, he was detailed to the WHO Nepal Country Office as the Team Lead for the Immunization Preventable Diseases Unit and to the WHO Ethiopia Country Office, from 2004-2007, coordinating programmatic and surveillance activities for vaccine-preventable diseases.

Dr. Schluter graduated from the Creighton University School of Medicine in 1990 and received a Master of Science in Public Health from the University of Colorado in 1995. He completed residency training in both Family Medicine and General Preventive Medicine and Public Health. Vice President, Advocacy *UN Foundation* Peter Yeo joined the UN Foundation and the Better World Campaign in February 2009 with over twenty years of legislative, analytical, and management experience. Prior to arriving at UNF, Yeo served for ten years as the Deputy Staff Director at the House Foreign Affairs Committee. He led the successful negotiations for the landmark HIV/ AIDS, Tuberculosis and Malaria Act of 2003, commonly known as PEPFAR, and the successful \$50 billion reauthorization of the law in 2008.

He also served as a Deputy Assistant Secretary at the U.S. State Department during the second Clinton Administration, where he led the negotiations around repayment of U.S. arrears to the United Nations and was part of the U.S. delegation to the Kyoto climate negotiations.
